United Development Co. (UDCD)

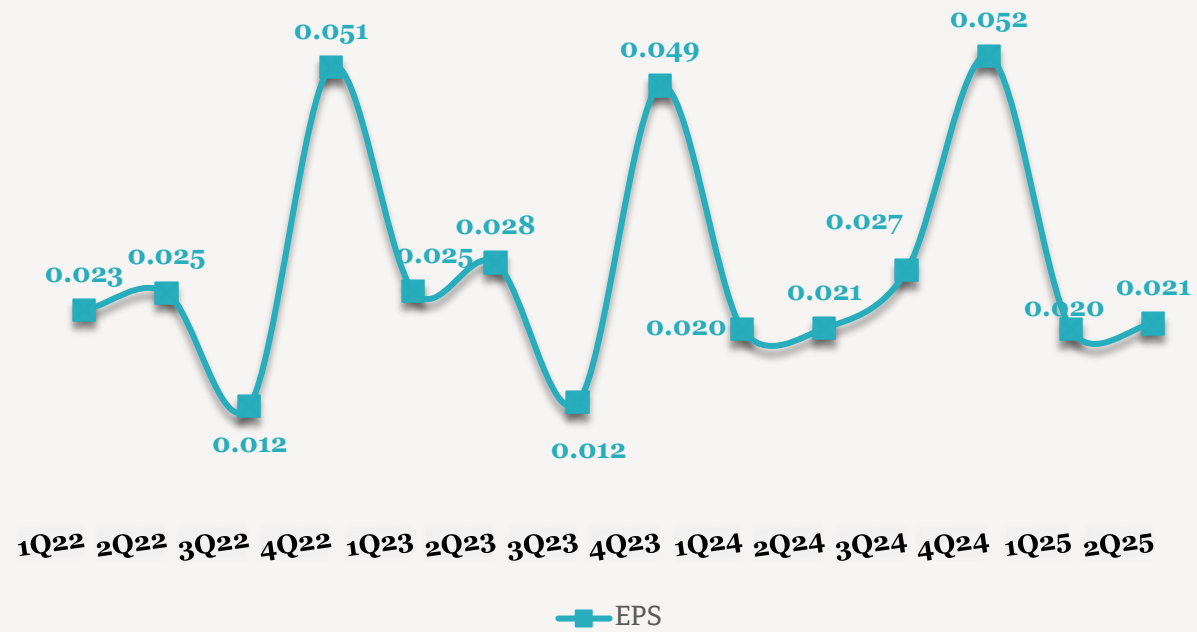
- > Net profit increased by 2.6% YoY (+3.2% QoQ) to QR75mn in 2Q2025, due to higher revenue. For 6M2025, net profit rose 1.2% to QR147mn.
- > Revenue rose by 236.3% YoY (-37.0% QoQ) to QR428mn in 2Q2025. For 6M2025, revenue rose 85.0% to QR1,106mn.
- > Gross profit grew 238.8% YoY (-30.4% QoQ) to QR122mn while the corresponding margin increased by 0.2ppts YoY to 28.5% in 2Q2025. For 6M2025, gross profit increased 43.8% to QR297mn.
- > Operating profit rose 133.5% YoY (flat QoQ) to QR95mn in 2Q2025 while the corresponding margin decreased by 9.7ppts YoY to 22.2% in 2Q2025. For 6M2025, operating profit increased 21.6% to QR190mn.
- > For 2Q2025 EPS came at QR0.021 vs QR0.021 in 2Q2024. For 6M2025 EPS came at QR0.042 vs QR0.041 in 6M2024.
- > As of 23rd July 2025, the stock decreased 6.9% YTD, Underperforming the QSE Index, which was up by 5.8% YTD.
- > The stock is currently trading at a TTM P/E multiple of 11.0x.

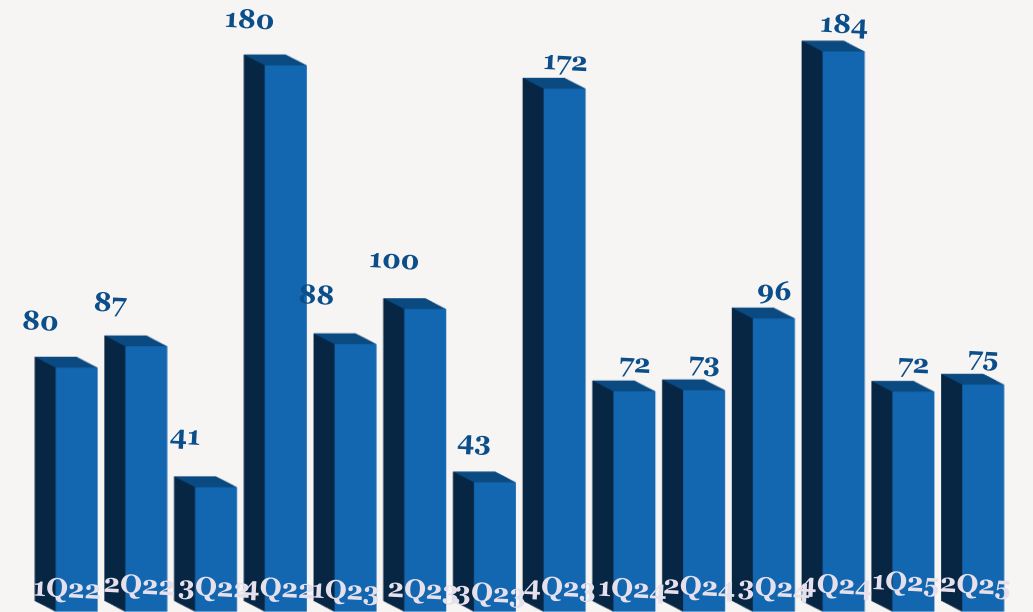
